 - ii. Question regarding Creditors. Money was paid in 2020 as a 'payment in advance'.

- f. Vote of thanks goes to Bryce Gorrell for his work as Auditor for 2021.

6. Registration and Subscription Costs

- a. Fees for 2022 subscription are to be \$0 for 2022.
- b. Question brought up around insurance for a \$0 subscription. Graham Cooper assured that insurance is a separate matter under Rugby Australia policy. Graham Cooper will confirm this.
- c. Question regarding the impact this would have on our financial situation if the 2022 subscription is \$0.00 for all members. The association has received approximately \$2500 for registration fees in each of the last two years. Given that for both 2020 and 2021 there was no presentation night, exchanges, or other planned expenditures due to the pandemic, it is considered that, for 2022, that Association has the fiscal resources to accommodate this. It was stressed this was a measure to be considered for the 2022 season only.
- d. That 2022 subscription be \$0.00 for all members, pending RA confirmation that insurance for referees is not affected. **Proposed** Amy Kilmister, **Seconded** Matthew Hogan. **Motion carried**
